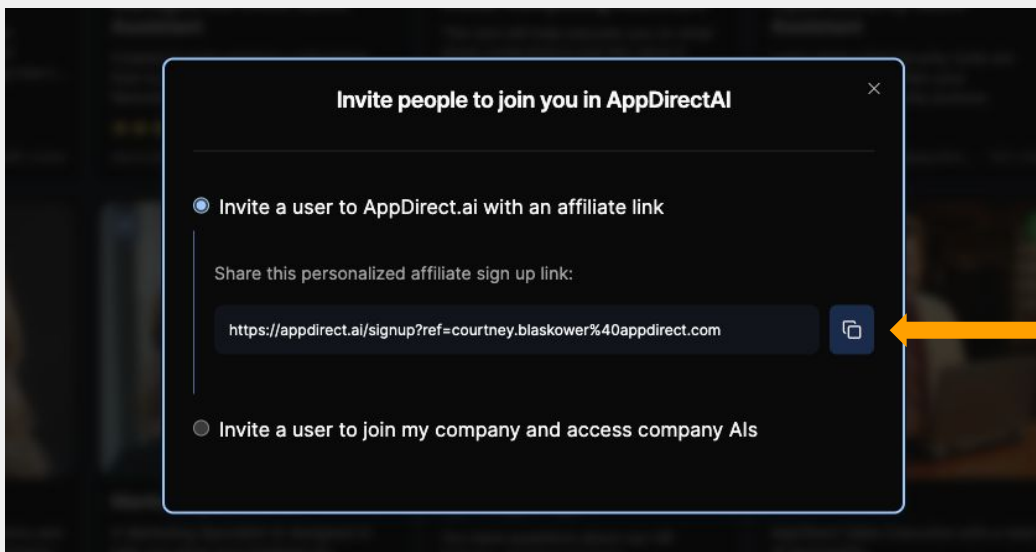


Frequently Asked Questions

Question: How can I refer my customer and ensure attribution for that account?

Answer

- You first need to set up your own account on [Appdirect.ai](https://appdirect.ai).
- Once the account is set up, click on "Invite" at the top right and a modal window will appear.
- Select "Invite a user to AppDirect.ai with an affiliate link".
- You can then copy the URL and share this link with your customer to attach the customer to your account.

Question: If I sign up for an account, will I receive commissions on my own billing?

Answer

- No. You will only receive commissions on paid customer accounts attributed to you.

Question: Can anyone, even without an AppDirect AI account, chat with an embedded AI on another webpage?

Answer

- Yes, anyone who can access the webpage can interact with the AI.

Question: Are AI chats and user interactions tracked when the AI is embedded outside of AppDirect AI?

Answer

- Yes, all chats are tracked under the creator's account, and the chat threads appear in the creator's chat list.

Question: Can I embed my AI in mobile apps?

Answer

- Yes, the widget is compatible with both web and mobile applications.

Question: What happens if I update my AI after embedding it?

Answer

- Updates to your AI app are automatically reflected in the embedded AI—no need to modify the embed code.

Question: How is the widget secured against unauthorized use?

Answer

- The embed code is URL-restricted, meaning it only functions on the websites or applications you specify.

Question: How is user data handled during interactions with the AI?

Answer

- All interactions follow AppDirect's strict privacy and security policies. Public users' chat sessions are stored locally in their browser and can be cleared at any time.
